- 1. Call to Order The 2011 Annual General Meeting of the NBART was called to order at 1445 by Beth Knowles, President of the NBART.
- 2. Quorum Report The quorum report was given by Troy Denton, Registrar of the NBART. Quorum requirements were met.

- 4. Business arising from minutes of May 4, 2010 No business arising was identified.
- 5. New Business:
  - a. Approval of Revised By-Laws Frederick C. McElman, NBARTs' lawyer from Stewart McKelvey | Barristers, Solicitors and Trademark Agent presented the revised by-laws for the Association to the membership. Fred explained that the changes were required to ensure that the NBART was functioning within the confines and limitations of the Act Respecting Respiratory Therapists. The revised by-laws are fully compliant with the Act and will allow the Association to fully meet its regulatory mandate. **Motion** made by Pam Trueman and seconded by Katherine Kowalski to approve the revised by-laws as pre-circulated to the membership.

- b. Financial Statement/Treasurer's report The cash flow summary and balance sheet for the 2010-2011 fiscal year were presented by Troy Denton. The revised by-laws require an annual summary review by an external accounting firm. Troy Denton will secure an external firm and have a summary review completed and posted to the website for the membership to view by September 2011. Further summary reviews will be completed and presented during the future AGMs. No questions were posed from the general membership.
- c. Executive Report Beth Knowles, President of the NBART gave the Executive report. The year 2010-2011 has been a busy year for the NBART, and I would like to take this opportunity to thank the members of the Executive and the Board for their hard work and dedication. For the most part we are a volunteer organization and could not function without those who are willing to commit their personal time to the NBART. We are a fledgling association and therefore have had a lot of groundwork to do, and in the past year we have accomplished much of the foundational work including:
  - Revision of bylaws
  - Development of the Continuing Competency Program for Respiratory Therapists
  - Initiated the process of policy and rule development.
  - As a member of the NARTRB we joined six of seven regulated provinces in signing the Agreement for the Registration of Respiratory Therapists from Unregulated Jurisdictions.
  - Committed to adopting minimum practice standards to be developed in collaboration with the Provincial Managers Group.
  - Committed to developing Documentation Standards.

I would also like to take this opportunity to thank Registrar Troy Denton for the terrific job that he has done as registrar and also for organizing this wonderful educational opportunity (NBART Education Forum) for the members. Thank you, Troy. I encourage members to become involved in the Association. We are lucky to have members like Kathy Kowalski, Patrick Hogan and Troy Denton who have a wealth of knowledge and experience to share. This is an exciting time of transition for the NBART and a great time to become involved.
